## Report of the President and CEO

The theme of this year's annual report, "The future is created by what we do today," aptly reflects the initiatives undertaken by the Caisse team throughout the 2012-2013 fiscal year.

In November 2012, we finalized our five-year strategic plan for 2012-2017, with the overarching objective of maximizing Caisse Financial Group's potential.

An organization's potential depends on the calibre of its staff, the capacity of its systems and technology, and a strong culture. Our strategic priorities are therefore focused on enhancing our processes and systems, developing our staff, creating a work environment that meets our employees' expectations, and incorporating leading-edge technology in our operations and service delivery to our members. It is all part of our commitment to achieving the operational excellence required to keep pace with our competitors. Our operational effectiveness strategy couples rigorous expense control with the optimization of our service offer to boost the Caisse's membership and business volume as efficiently as possible. Our strategic plan also includes strengthening our community partner role by providing ongoing support to our members' communities.

The financial services industry is rapidly changing. The regulations governing financial institutions are increasingly demanding, requiring more sophisticated systems to ensure compliance. Online services and mobile applications are gaining in popularity, our members want services that are easier to use and more accessible, and the new generation of Caisse members do most of their transactions online or via their cell phones. To ensure that the Caisse remains viable and competitive in this change-driven industry, we undertook a large-scale technological transformation in April 2013 that includes replacing our current banking system with state-of-the art technology that will give us the needed flexibility and capacity. This project will be ongoing throughout our 2013-2014 fiscal year and will require a considerable allocation of Caisse resources to make this project a success.

In March 2013, we launched online statements in response to the results of our June 2012 membership survey. "Mission Zero Paper" encourages all members to stop the printing of monthly statements and to access their monthly statement online via e-Caisse instead. As of the end of September 2013, more than 2,000 members had joined our zero-paper mission.

In September 2013, we signed two important vouth-focused partnerships with Université de Saint-Boniface (USB) and the Economic Development Council for Manitoba Bilingual Municipalities (CDEM) which will contribute to the continued vitality of our communities and develop a new generation of future Caisse members. For the next three years, Caisse Financial Group will be the official sponsor of USB's sports teams, Les Rouges, supporting the recruitment strategy initiated by USB to encourage postsecondary students to pursue their athletic careers while completing their postsecondary studies in French. Caisse Financial Group also signed a three-year partnership agreement with CDEM for delivery of the "Jeunes Enterprises" program, targeting more than 6,000 students in Manitoba's Francophone and Immersion schools to teach them entrepreneurship and financial management concepts from a young age.

Also in September 2013, Caisse Financial Group launched a new program, the "Money Kit for Students," which provides post-secondary students with customized products and services as well as online tools, at www.caisse.biz/kit, for effectively managing their money while they are in school. The opportunity to win \$500 in three annual draws serves as an incentive to save their money. This program is part of our larger mission to help youth become financially responsible adults.

Throughout the year, we continued our community partnerships, providing more than \$250,000 in donations and sponsorships to some 200 community projects and activities. The list of our recipients is available in our annual report and on our website. From January to March 2013, members who invested with the Caisse were given the opportunity to support a local community centre of their choice, resulting in \$17,715 in financial support being paid out to 20 local community centres.

This is how, today, we are creating a new Caisse: through a robust strategic plan, the roll-out of new technology and a commitment to a new generation of members and to our communities.

The Caisse's future also depends on its ability to generate solid financial results. In this respect, the future bodes well for our institution, which achieved excellent financial results in 2012-2013 despite continuing low interest rates and an extremely competitive market that puts steady pressure on our profitability. Our assets were \$1,120,243,207 as at September 30, 2013, an increase of 10.45% from last year. The Caisse sought to offer our members the best investment products possible with our Best Rate Deposits, which helped us achieve a deposit growth rate of 10.07%. Loan growth was also strong at 10.08%


for the year thanks to our Best Rate Mortgage, our commercial loans, and an excellent team of employees and their exceptional member service. Our gross operating expenses only increased 2.41% compared to the previous year as a result of our continued prudent management. The excellent loan and deposit growth combined with a modest operational spending increase helped to achieve a net income before other items and income taxes of \$7,391,088, an increase of 19.02% from the previous year, which also exceeded our budget forecast for the year.

The Caisse's current financial position is strong, with a level of capital of 6.98% compared to the minimum 5.0% requirement, and a risk-weighted capital of 11.16% compared to the 8.0% minimum. However, an increase in capital requirements is expected shortly and financial institutions, including the Caisse, will have to comply. The Board of Directors therefore thought it prudent not to declare a patronage refund for the 2012-2013 fiscal year in order to have the needed flexibility to meet these future requirements.

In closing, we would like to thank our members for placing their trust in us and choosing to bank with Caisse Financial Group; we do not take your support for granted and sincerely appreciate this gesture of solidarity with your co-operative. We wish to extend our heartfelt thanks to the Board of Directors for their cooperative commitment and invaluable support in creating the future Caisse. We also want to thank our employees for everything they do on a daily basis to maintain and build solid relationships with our members.

Creating the future... with a technological transformation

The financial services industry is constantly changing, and changing fast. As technology becomes more sophisticated, mobile and online financial services are gaining in popularity. Technological advances also make it possible to enhance operational efficiency, provide faster service, and introduce new products and services.

Caisse Financial Group will therefore be undergoing a major technological transformation that involves implementing a new banking system and revamping our operational systems. This transformation will optimize our: operational effectiveness, service in our branches, and mobile and online services, such that the Caisse can live up to our members' expectations.

This technological transformation is a highly ambitious undertaking, however the Caisse has had a strong track record of pioneering new products, services and technology over the course of its history. Right from the start, the Caisse broke new ground as Manitoba's first financial services co-operative. When it was first implemented, our current banking system was very innovative for its time, being the first among Manitoba's financial services co-operatives to process data in real time. As well, the Caisse was the province's first financial services co-operative to offer telephone banking and direct payment services to its members.

This latest initiative is being developed with the same pioneering spirit.

The benefits of this shift from the current system to enhanced technological tools will be very important for the Caisse and our members. The versatility and unlimited options offered by the new technology will help us create the future Caisse. A number of currently manual operations will be processed automatically by the new system. As a result, service will be better, faster and more efficient. Our system overhaul will also introduce new features and functions in the subsequent project phases; new online services and smart phone and tablet apps will facilitate transactions, giving members banking services and solutions at their fingertips, with a simple 'CLICK'.

Creating the future Caisse hinges on the capacity of our systems and technology. Once our new system is in place, the Caisse will improve its operations and member services, and be able to adapt to future technological advances.

We therefore entered into key partnerships this past year with two organizations that are also actively involved in youth development: Université de Saint-Boniface (USB) and the Economic Development Council for Manitoba Bilingual Municipalities (CDEM).

## Partnership with USB: Les Rouges

The three-year agreement between USB and Caisse Financial Group will give Manitoba's

young Francophone athletes the chance to play competitive sports while attending a French language post-secondary institution.

"Extracurricular activities such as sports are essential to young people's personal development and education. Involvement in sports teaches cooperation, putting common goals ahead of personal ones, and achieving success through a collaborative effort with the whole team. ## Partnership with CDEM: Jeunes Entreprises du Manitoba

With this in mind, the Economic Development Council for Manitoba Bilingual Municipalities (CDEM), in partnership with Caisse Financial Group, launched the Jeunes Entreprises du Manitoba program to educate students about the major economic issues and challenges of entrepreneurship. ## New "Money Kit for Students" Program

In September 2013, Caisse Financial Group launched its new "Money Kit for Students" program for youth aged 18 to 25 pursuing a post-secondary education. Tailored to the specific needs of students, the Money Kit provides services such as the new Student Account with free, unlimited transactions. The new Savings Account for Students encourages students to save money for their tuition and gives them the chance to win \$500 three times a year. Students must save at least \$500 in their savings account to be eligible for the draws.




